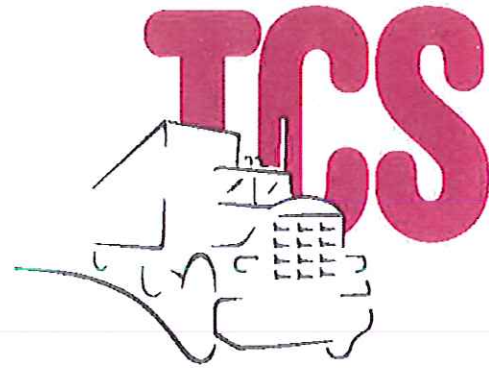

SOME COMMON QUESTIONS

Q: Do I need an IFTA license?

A: If your trucks travel interstate and their GVW exceeds 26,000#, and you burn diesel fuel, then, yes, an IFTA license is required.

Q: Does my company need federal authority in order to operate legally?

A: That depends. If you operate as a private carrier (haul only your own products), federal authority is not required, although certain states do insist that you file for authority in their state if you cross their borders. If you operate on a for-hire basis across state lines or contract with suppliers to haul their products, then you are required to file for federal authority.

Q: I just haul in Arizona. Do I need a USDOT number?

A: Yes, If your trucks are licensed for over 26,000# GVW, you will be required by the Arizona DOT to file for a USDOT number at your next license renewal date.
